Las Lomitas Changes on PCO's

New or updated PCO's cost estimates since last report:

- \$241k Increase for Plug-In's reconstruction estimate
- \$50k Seismic revisions in Wings 1 and 2 due to existing conditions
- \$40k New sidewalk at Wing 1 and parking lot
- \$47k Replace/ repair ceiling grid, tile and structure in Wings 1 and 2
- \$25k 2 Story 2nd floor concrete coatings
- \$16k Replace missing roof joists at old skylights
- \$16k Patch drywall in 2 Story

□ \$435k - Total increase in PCO estimates

La Entrada Changes on PCO's

- New or updated PCO's cost estimates since last report:
 - \$150k Jenson/ Admin Unforeseen Conditions for structural repairs
 - \$103k Misc. minor items (structural at new door, security system changes, marker board replacements, exterior lighting conduit, added mold abatement, added site concrete, office and classroom casework revisions, irrigation revisions, fire dampers, and addition lighting)
 - o \$65k Ceiling replacements due to rodents and structural upgrades
 - o \$50k Seismic revisions in Jenson Hall due to existing conditions
 - \$40k Increase in prior estimate for demo, grading, and concrete work at Wings 1, 2 and Library
 - \$37k Schedule acceleration for Summer work completion
 - \$20k New water heaters
 - \$20k Scaffold deck for safety at Jenson and Wing 3
 - \$20k Library gutter repairs
 - \$20k Replace faucets in Wings 2 and 4
- □ \$525k Total increase in PCO estimates

Budget Update Summary

- □ \$960k Estimated combined Change Order increase
 - \$525k La Entrada estimated increase
 - \$435k Las Lomitas estimated increase
- □ -550k Estimated overage of combined contingencies:
 - \$100k La Entrada estimated balance
 - -\$650 Las Lomitas estimated balance
- All budgeted contingencies depleted (\$2.96 mil in-lease + \$1.08 mil outside of lease)
- □ \$889k Overall Program Balance
 - Set aside for future projects
- □ \$339k New Program Balance
 - Program Balance (Fund 40) reduced from \$889k. Originally hoped to use remaining balance for future projects.
- Any additional insurance reimbursement funds received from SMCSIG will increase amount of available funds

*Discovered damage is much more extensive that previously known. SMCSIG has informed LLESD that they plan to only reimburse their initial estimate of \$138K.
