Mold Remediation and Testing

- It has been confirmed that the mold was only present at Las Lomitas Wing 5.
- All mold remediation work has been completed. Work was performed by a licensed and certified hazardous material contractor and work was overseen and tested by an Industrial Hygienist.
- Proposed corrective measures to prevent mold from reoccurring have been approved by the Division of the State Architect.
- San Mateo County School Insurance Group (SMCSIG) has tentatively agreed to pay insurance claim. Costs have been submitted.
- Additional mold testing and inspections have been completed at both Las Lomitas and La Entrada by the Industrial Hygienist.
- No remaining mold was detected.

Las Lomitas Schedule Impacts

- Project was about three weeks behind schedule prior to the discovery of mold due to various unforeseen conditions.
- Also, shipment of the Mechanical Units (HVAC) have been delayed by manufacturer due to supply chain issues.
- These are concurrent delays with mold discovery and remediation work.
- Materials and equipment have been ordered for all phases. Therefore, items like HVAC units should not impact other phases.
- Lessons learned from the first buildings will apply to the rest, so the overall schedule will accelerate.
- XL Construction believes that some of the Phase 1 delays can be absorbed in subsequent phases. However, the overall contract duration will need to be extended.


Las Lomitas Current Schedule

- Phase 1 (Rooms 1-8): Started June 21, 2022 Was to have been completed November 10, 2022.
 - Revised completion Date is January 14, 2023
 - Revised move dates are January 16, 2023 thru January 20, 2023
- Phase 2 (Rooms 19-24): Original completion date was March 27, 2023
 - Revised start date is January 23, 2023
 - Revised completion date of June 3, 2023
- Phase 3 (Rooms 11-18): Original completion date was August 17, 2023
 - Revised start date is June 12, 2023
 - Revised completion date of October 21, 2023
- □ Phase 4 (Cano Hall, Library and 2 Story):
 - No change to the original start and completion dates. Construction start of June 19, 2023. Construction completion August 2, 2023.


La Entrada Schedule Impacts

- Project is about three weeks behind schedule due to various unforeseen conditions.
- Also, shipment of the Mechanical Units (HVAC) have been delayed by manufacturer due to supply chain issues.
- □ These are concurrent delays.
- XL Construction believes that the delay in Phase 2 can be absorbed in Phases 3 and 4.
- Mechanical units have been delayed. At this time, we anticipate receiving them shortly after occupancy of the Phase 2. Space heaters will be provided in the occupied classrooms.
- Materials and equipment have been ordered for all phases.
 Therefore, items like HVAC units should not impact other phases.
- Lessons learned from the first buildings will apply to the rest, so the overall schedule will accelerate.
- □ Overall project completion date remains unchanged.

La Entrada Current Schedule

- □ Phase 1 (Underground Utilities): Completed on schedule.
- Phase 2 (40's Wing): Started June 20, 2022 Was to have been completed November 16, 2022.
 - Revised completion date is December 10, 2022
 - Revised move dates are December 12, 2022 thru December 16, 2022
- Phase 3 (Room 1-5, Science Rooms 11-12): Will have two start dates to help recover time.
 - Wing 2 (Rooms 11 and 12) Revised start date is November 7, 2022
 - Wing 1 (Rooms 1-5) Revised start date is December 19, 2022
 - Revised completion for both Wings is April 7, 2023
- □ Phase 4 (20's and 30's Wings):
 - Revised start date is April 17, 2023
 - <u>Same</u> completion date of September 15, 2023
- Phase 5A (Admin and Jensen): June 20, 2023 October 5, 2023. <u>Same as original completion date.</u>
- Phase 5B (Library and Gymnasium): June 20, 2023 July 28, 2023. Same as original completion date.




